Providence Alaska Medical Center (PAMC) is a 394 bed, tertiary care, community hospital offering ASHP-accredited Pharmacy Practice and Oncology Pharmacy Residency positions.

Pharmacists at PAMC provide a full range of clinical and distributive services to a broad array of acute care and home infusion center patients. Resident experience will be gained in required and elective rotations. Staffing, pharmacy practice management and drug information/P&T experiences will be longitudinal.

PGY-1

- Required rotations include internal medicine, inpatient family practice, critical care, pediatrics, infectious disease, progressive care with nephrology and cardiology emphasis, pharmacy practice management (longitudinal)
- Elective rotations include neonatal intensive care, oncology, surgery, infusion center, clinical or operations managemnt

PGY-2

- Required rotations include inpatient adult, outpatient adult, pediatric oncology
- Elective rotations include palliative care, infectious disease, nutrition, genetic counseling, private practice, radiation oncology, bone marrow transplant

Three references are required via the Standardized Reference Form Available In Phorcas.

Special Requirements in Addition to Standard Requirements in Phorcas: The Narrative Comments section on Standardized Reference Form is NOT optional and must be completed by the person writing the reference. If you have worked in a hospital or community pharmacy, please include a minimum of one reference from your supervisor at that institution. If you have not, but have served in a role related to health care or science please include a reference from that respective supervisor. Also include one reference from an acute care clinical rotation preceptor or another rotation if you have not had an acute care rotation yet.

For on-track resident applicants (starting in July for PGY-1) we participate in the ASHP matching program. The ASHP website has information regarding the process (www.ashp.com). Our Residency Matching Program Code numbers are:
