Post Graduate Year 1 Residency Program: Preparation for Advanced Pharmacy Practice

Comprehensive Training in Acute and Ambulatory Care

At Providence St. Patrick Hospital (PSPH), you will have a chance to develop advanced skills in contemporary pharmacy practice. The residency is flexible, permitting us to individualize the emphasis of the program to meet your specific professional goals. The Providence organization believes strongly in patient-centered, clinical pharmacy practice. Through our PGY-1 Pharmacy Residency, you will gain the broad experience necessary to succeed as a clinical pharmacist.

Pharmacy Residency Program Overview

The Residency Program is committed to developing pharmacy practitioners with the knowledge and skills required to promote and deliver high-quality pharmaceutical care services. Our PGY-1 Pharmacy Residency is designed to meet the requirements as outlined by ASHP. Pharmacy residents completing a PGY-1 Residency at PSPH will gain competency in the management of patients on all parts of the acuity spectrum, from ambulatory to critical care. Residents are responsible for achieving optimal drug therapy outcomes as a part of interdisciplinary healthcare teams. Residents will have the opportunity to participate in a longitudinal ambulatory care experience, and they will also be involved in successful transitions of care to help prevent medication-related hospital readmissions. The resident will learn to work independently in all assigned practice areas. Residents will have opportunities to educate others by presenting clinical in-services, teaching and precepting pharmacy students. The goal is for each pharmacy resident to grow into an experienced clinical pharmacist, be proactive and assertive in their interactions with other staff and disciplines, and foster an awareness of local and national pharmacy issues.

Choose a Residency Project

All residents will complete a major year-long project. Projects are developed by the resident in conjunction with the Department of Pharmacy Administration based on resident interests and departmental needs. The project shall be presented at the Mountain States Residency Conference held each spring and must be submitted in written form prior to the completion of the residency year. In addition, you may submit your project to the ASHP Midyear Clinical Meeting.

PSPH Department of Pharmacy

The Pharmacy Department provides 24-hour acute care services. These include centralized distribution, decentralized clinical services, an ambulatory anticoagulation clinic, family medicine refill authorization services, and several retail pharmacies. Part of your training will involve staffing the main central distribution pharmacy every third weekend in order to help ensure you are competent in the operational side of hospital pharmacy and understand how it impacts patient care.

Receive Salary, Benefits and Travel Opportunities

As a pharmacy resident, you qualify for employee benefits. The benefits package will include medical, prescription, vision, and dental coverage (for you and your dependents), as well as 12 days of paid time off. Administrative leave is provided for ASHP Midyear and Mountain States Residency Conference meeting attendance.

Applicant Requirements

To be considered for the PGY1 Pharmacy Residency, you must be registered with the ASHP Matching Program. All applications are submitted via PhORCAS. Prior to the start of the program, the resident will have graduated from an ACPE accredited college or school of pharmacy and shall be licensed or eligible for licensure in the State of Montana. Applicants must pass all Providence employment screenings including but not limited to drug screens, background and health screening. Applicants must be a U.S. citizen. Strong residency candidates must possess excellent verbal and written communication skills, demonstrate a pattern of professionalism and leadership, as well as being committed to patient focused pharmaceutical care.

How to Apply

To be eligible for the PSHP PGY-1 Pharmacy Residency, applicants must submit the following via PhORCAS:

- Cover Letter, stating reasons for applying to a PGY-1 and why you want to train at PSHP
- Curriculum Vitae
- Three letters of professional recommendation
- One official copy of college of pharmacy transcripts
